MARKET INTERPRETATION

The real estate market in **Beaconsfield (Beaurepaire)** is currently in a buyer's market with a strong buyer advantage, based on current supply levels relative to sales activity. With approximately **8.4 months of inventory** and an average selling time of **89.5 days**, buyers benefit from increased choice and negotiating leverage, while sellers may face greater competition from other available properties. During the 12-month period ending August 31, 2026, a total of **33 homes sold**, while the median sale price reached **\$985,000**, representing a **4.0% increase** compared to the preceding 12-month period. Although current market conditions favour buyers, accurate pricing and effective property presentation remain important factors in attracting qualified purchasers and achieving optimal results.
